The Bombay, Calcutta, Cochin, Jamnagar, Goa, Kandla, and Bhavnagar Associations formed the Federation. Today, the Federation of Freight Forwarders Associations in India (FFFAI) is the Apex Body and the Sole Representative of 24 Member Associations from all over India representing 5000 Custom Brokers and Freight Forwarders (employing over 1,00,000 people) and controlling ninety percent of India's international logistics trade. In addition, organizations that are directly or indirectly connected with freight forwarding, shipping, and commerce are also associated with FFFAI.

Federation of Freight Forwarders Association of India (FFFAI) fulfilled its desire to promote a training establishment for Customs Brokers, Freight Forwarders, Logistics Companies by setting up the "Indian Institute of Freight Forwarders" in 2004. Objectives

- ·Assist the logistics staff in creating plans and overcoming obstacles in cross-border commercial dealings.
- ·To introduce the audience to the process of building strategies and to provide a proper framework and perspective for doing so.



About the Program

Logistics is an integrated arm in manufacturing and distribution companies. In today's world global linkage is an absolute necessary for firms. India has resolved to make its "Make-in-India" initiative a success and that makes "Global Logistics" crucial and inevitable. Though India is rich in high-level human abilities and ideas, it still requires a clear path to translate these into excellence in the workplace. Hence, in order to upgrade the knowledge of participants/professionals in Logistics and Freight Forwarding techniques in Export & Import procedures and to enhance their operational competence, the Indian Institute of Foreign Trade (IIFT), Kolkata in collaboration with Federation of Freight Forwarders Association of India (FFFAI) will offer an online Certified Professional Program on "Global Logistics Management & Freight Forwarding Operations (CP-GLMFFO)"including the weekdays/weekends.

Examinations for all the semesters would be conducted mostly on hybrid mode. Depending upon the availability of the students, if they will be in the campus, exams can be conducted offline also.

Duration

The duration of the Course is 160 hours of speech over a span of four months and classes would be held during the weekends (online) i.e. Saturdays (for 3 hours) and Sundays (for 6 hours). The course will be conducted through the hybrid mode.

There will be a 4-day (24 hours) contact week at IIFT Kolkata where the participants have to physically attend the classes at IIFT.

Online classes will be conducted through the MS Team App.

The course-wise hour distribution is mentioned below:

- 1. Interactive Session 140 Hours(80 hours online class+60 hours internship based learning)
- 2. Sea Port Visit 10 Hours
- 3. Dissertation Work 10 Hours

Course Credit

Courses are listed as 1, 2 and 3 credit courses depending on the expected workload of each course. It is a total 16 credits course (160 hours), with 140 hours of interactive session, 10 hours of port visit & 10 hours of Dissertation project.

Course Fee

The course fees will be Rs. 100,000/- + GST per participant to be paid to IIFT. This course has a mandatory requirement for port visit for which students will have to bear the food and lodging cost


