#### **Objectives of MDC 2022**

- Opportunity to discuss ongoing research with other doctoral students and leading academicians in the field of management.
- Attract Scholars working in the above fields of doctoral research, which will help in knowledge sharing, understanding and promoting the best practices/barriers and motivate researchers to address the new gap/issues.

#### Call for Extended Abstract/ Papers

Doctoral students and faculty members who have submitted their thesis or pursuing Ph.D. programme in the field of Management across areas, including: Accounting, Economics, Finance, Human Resource Management, Organisational Behaviour, Logistics, Operations & Supply Chain management, Business Laws, Business Strategy, Marketing, Data Analytics, Systems, Soft Computing and any other allied area of Management can submit their extended abstract in the following two ways:

## Type I: Research Design Presentation

Papers are invited from scholars who are in their initial stages of Ph.D. Research scholars who have completed their coursework and made progress in research proposal are expected to participate. Participants are not expected to present any estimation results and are requested to follow the following structure for paper submission: Introduction, extensive literature survey, research gaps, objectives, proposed hypothesis, proposed methodology, expected contribution to the literature.

#### Type II: Advanced Research Paper Presentation

Papers are invited from scholars who are in the advanced stages of thesis. Research scholars who have made progress in thesis work and are about to submit their thesis or have submitted their thesis and are waiting for defense are expected to participate. Participants are requested to follow the following structure for paper submission: Introduction, extensive literature review, research gaps, objectives, hypothesis, methodology, interpretation of results, conclusion and policy or managerial implications.

## Paper Submission Guidelines

The participants may submit full paper or an extended abstract. Full paper (not exceeding 7000 words) and extended abstract (not exceeding 750 words) should be submitted in the following format:

- 1. Introduction and motivation
- 2. Literature Review
- 3. Objectives
- 4. Data & Methodology
- 5. Results and findings (only for Type II)
- 6. Contribution & Conclusion

#### **Review Criteria:**

All papers will be blind reviewed and only those papers approved by the reviewers will be selected. The criteria for evaluation by the reviewers are as follows:

#### Relevance

Whether the subject of the paper contributes to any current/unresolved problems in the relevant discipline.

#### Methodology

Whether the paper uses appropriate methodology.

#### Contribution

Whether the paper contributes to the theory of a management subject or finance or economics.

Whether the paper provides relevant/novel policy or managerial implications.

#### **Best Paper Award**

All submissions will be considered for best paper awards in the following core streams.

- 1. Accounting/Economics/Finance
- 2. Human Resource Management/ Organisational Behaviour
- 3. Logistics/Operation Management/Supply Chain management
- 4. Business Laws/ Business Strategy/ Marketing
- 5. Data Analytics/ Systems/ Soft Computing.

Detailed workshop agenda will be mailed to the participants whose paper will be shortlisted for presentation.
