#### BACKGROUND

Abhivyakti Foundation is a national level organization founded in the year 23rd March 2001, registered under Societies Registration Act XXI of 1860, Govt. NCT of Delhi by a group of young and dedicated development workers. The organization is committed to bring about change in the society with special focus on self-reliance, social equity and justice. The core values of the organization are change, self-reliance, human dignity and participatory development. The major focus of the organisation is on improving the social and economic conditions of women and children, especially the girl child. The thrust areas of its activities are education, health, livelihood and empowerment. The organizational activities are variegated and widespread. Its activities concentrate on women and adolescent girl as well as children belonging to poor and backward communities both from rural and urban areas of four regions namely Delhi, Uttar Pradesh, Punjab and Haryana. In addition, Abhivyakti Foundation also worked with high-risk groups like sex-workers and drug users. Its areas of operation are based on projects supported by different government and non-government organizations. In Delhi, the interventions are executed in urban areas with special focus on slum areas, authorized and regularized colonies of central and northern districts of Delhi, Haryana. Operation areas consist of both rural and urban areas.

Abhivyakti Foundation is an organization dedicated to the protection, promotion and well being of the weaker and marginalized section of our society. It is committed to provide overall development opportunities and participation of community at large in the welfare and protection.

We are engaged with the women, children, Transgender and community at large belonging to poor and backward community both from rural and urban areas of four states namely U.P, Delhi, and Punjab & Haryana. In addition, we have worked with High Risk Groups like MSM, FSWs and IDUs.

# AREA OF OPERATION


Abhivyakti Foundation is working in four states namely Delhi, Haryana U.P and Punjab. The areas of operation are based on projects supported by different govt. and non-govt. organizations.

**In Delhi**, the interventions are executed in urban areas with special focus on slum areas, authorized and regularized colonies of central and north districts of Delhi.

**In Haryana**, operation area consists of both rural and urban. In rural areas, we are covering three districts namely Faridabad, Fathehabad and Mewat while in Palwal, we are covering urban areas.

In U.P state, we covered semi-urban area in districts namely Ghaziabad and Noida District.

In Punjab, we have recently launched the programme in urban areas of Jalandhar district.



Various programme interventions of the organization are executed by following core strategy:

1.	Health & Hygiene
2.	Education
3.	Women empowerment:
4.	Child development: crèche, DCC at GB Road
5.	Education: BPP, Research
6.	Community Mobilization
7.	Skill development & capacity building

# 1. HEALTH & HYGIENE

The health initiatives are focused on both preventive and curative aspects of women and children as well as vulnerable groups like High Risk Groups of HIV//AIDS i.e. IDUs, MSMs and FSWs. The activities consist of awareness generation, behavioral change, Mobile health services, advocacy, networking and linkages with existing govt. health machinery. The programmes are executed in both urban and rural areas.

The special groups are covered under 'targeted intervention programme'. We are also commitedly engaged with Learning Site "Hifazat" and a Community Support Center at Punjab.

# 2. EDUCATION

Education has been a major thrust area of the organization since its inception. Educational efforts are geared for promoting both formal and informal education with special focus on girl child. As a part of non-formal educational programmes, we have catered to Sarva Shiksha Abhiyan, Remedial classes for children, BPP Course and condensed course from IGNOU. The interest in excelling towards different fields had encompassed us to take up research studies too. One such research studies ongoing is "The Study of Critical Analysis of Women in Science and Technology with special focus on Minority at CSIR New Delhi and JNU under National Commission for Women. We had also worked on the Household Baseline Survey Report on the Health Status of women at Burari.

# 3. Women Empowerment:

With the increasing rise of violence against women, the need to generate legal aid and awareness, under the aegis of Delhi Commission for Women a, Mahila Panchayat Programme is implemented by the organization. In this programme, women are given awareness regarding the various Rights she can execute through organizing meetings and camps. Cases are handled by the team however unresolved and complicated cases that require law and order are forwarded to the Commission.

We also work with Female Sex Workers of GB Road for promotion of identity and dignity of the targeted group by offering counseling, health care and entrepreneurial services.

We also worked with adolescent girls under Kishori Shakti Yojana programme.

# C. SKILL development and Capacity Building:

As a part of future strategy, we are envisaging to launch new market oriented interventions for generating financial sources of the organization. The idea is to provide recognition and economic

sustainability to the artisans for their innovative works as well as providing a base for marketing of their products along with generating revenues for initiating development endeavors.

With the support of NABARD, MEDP is primarily involved with articles made of jute of various types like bags, file folder, carry-bags, and decorative materials which are showcased and sold at fairs. We also organized selling the tea products of HINDUSTAN UNILEVER LTD. Other vocational programmes include tailoring, embroidery, beautician and pottery making.

# D. COMMUNITY MOBILISATION

We firmly believe in mobilizing the targeted community for taking self initiatives for improving their socio-economic conditions. We have been mainly involved in formation of Self-Help Groups of women who belong to poor and backward community. These groups were strengthened through various capacity building and linkages with financial institutions.

For community mobilization and raising awareness we organized Awareness Generation Programmes under different supporting organization. We have been continuously engaged with Indian Environment Society for National Environment Awareness Campaign since 2007. Awareness generation on Anti Quackery under Directorate of Health Services and many other AGP at project level are also organized. These include health & hygiene, education and global warming.

# E. MICRO INSURANCE PROGRAMME

We are running insurance programme in collaboration with LIFE INSURANCE COMPANY for low income group community who do not have fixed and stable income. The scheme has provision of minimum sum assured of Rs. 5,000 and maximum of Rs. 30000. The client is required to pay minimum Rs. 25 per week and Rs. 100 per fortnight as a maximum premium. As a part organizational services, we assist the clients in getting the disability and accidental benefits.

# G. OUR TEAM

The Team consists of committed employees having diverse social, educational and variegated experiential background. We had focused on social inclusion and hence without any differential treatment the staffs are shortlisted for holding different positions of the various projects.
