The representatives of participating agencies were requested to put forward their doubts or points which needs clarifications. Various request / questions raised by them and the clarifications was provided by IIFT committee are mentioned as below:-

S. No.	Pre-bid query	Comments from IIFT
1.	Whether the experience of canteen services in Schools count as work experience.	It was clarified that only "similar works" can be counted as work experience, as per clause 4(b) and clause 4(c)(iii) of the N.I.T.
2.	Interpretation difference in Clause 4(b) and Clause 4(c) of Section-1	Clause 4(b) of Section-1 of the N.I.T. document is hereby rephrased as <i>"The bidder or its parent firm should be in business of providing similar services at least during the last 3 years and should have FSSAI license as on last date of receipt of tender"</i>
3.	Whether the experience of canteen services in Government of India events/Museum count as work experience.	It was clarified to the intended bidder that as per Clause 4(b) and Clause 4(c) (iii) of Section-1 If "similar works" is for the last 3 years, only then it can be counted as work experience.

4.	Whether crockery/cutlery is to be provided by IIFT or arranged by vendor	It was clarified that all such things have to be arranged by vendor themselves.
5.	Whether gas charges are to be paid by vendor.	It was made clear that IGL charges are to be paid directly by the vendor (Clause 26 of Section-5 Part-B)
6.	Whether canteen services are to be provided only on working days.	It was made clear that canteen remains open on all days, including Saturday and Sunday, to cater to various ongoing programmes at IIFT campus.
7.	In Which buildings Tea/Coffee in bulk (mentioned in Table-F of Section-9(B)) are to be served	Tea/Coffee in bulk is to be served in Administrative block and Academic block of the IIFT campus.
