The representatives of participating agencies had raised their doubts / queries. In this regard, the clarifications / amendment provided by IIFT is as below:

1.	Annexure – B Client Certificate regarding performance of contractor	1. Other Performance certificate format will be consider but having all the parameters as per Annexure-B 2. Consolidated feedback will be consider for Sl.No. 9 i.e. Comments of capability of contractor
2.	EMD payment	Bidders can submit EMD in DD also apart from NEFT/RTGS
3.	Regarding any minimum service charges (%)	As per tender document
4.	Payment of wages	As per tender document
5.	What quantity of housekeeping machinery required?	The bidders has to himself asses the machines required for providing services to the Institute as per Scope of work (Section 3) and nothing extra shall be paid on this account
6.	Regarding bonus to outsource staff	As per Bonus Act 1965 Section 32 (v)(b) and the Code of Wages 2019, the payment of Bonus does not apply to Universities and other educational institutions
7.	Which Make/ Manufacturer of material to be supplied list of materials mentioned in Table – C?	Bidders need to supply material as per Make/ Manufacturer mentioned in Annexure-4

8.	The agencies attending the pre-bid meeting are only allowed / eligible for participating in the bid and others are not allowed and will be rejected?	No, attending the pre-bid meeting is not compulsory. The bid is open for all to participate, as per the eligibility criteria and terms and conditions mentioned in the bid document.
9.	Is garbage disposal needs to be handle by the agency or the Institute?	Only segregation of garbage to be done by the agency to the collection point. However, disposal will be handle by the Institute/MCD.

- **Point (2) in Annexure - A** the past 7 years experience shall be read as past 5 years.
- **SI (11) point (iii) in Annexure - B** will be read as Fair/Satisfactory.
