- Q1. As desired in tender, service uptime SLA of 99.5% should be allowed as per industry standard instead of 99.9% service uptime.
- Q2. The average time to deliver a link in fibre is 6-8 weeks, would request you to increase the timeline for delivery.
- Q3. IIFT is requested to extend the Bid Submission date by around 15 days.
- Q4. Please clarify on the scope of DNS requirement, it is understood that the bidder would be required to do reverse DNS entries only if required.
 - (i) Request you share the router details on which ILL Link will be terminated;
 - (ii) All configurations on IIFT BGP router will be done by IIFT itself, please confirm;
 - (iii) CPE Router Hardware management will be done by IIFT, please confirm;
- Q5. To confirm whether bidder needs to provide the dedicated Onsite Engineer for this project? If yes, then IIFT is requested to provide seating space, desktop/Laptop, Internet Connection, LAN, Telephone line, Temporary ID Card, etc for Residential Engineer.;
- Q6. IIFT is requested to confirm whether Bidder / ISP needs to provide the CPE router for termination of ILL link along with this link OR Link will be terminated on IIFT provided CPE router.
- Q7. IIFT is requested to consider the acceptance of the link to be WAN Ping Test (PE to CPE) & successful browsing of IBW link on connecting laptop to Denmark device.
- Q8. IIFT is requested to provide the acceptance of link within 2 days posthandover of link & acceptance of link to be site wise (i.e. on individual site wise).
- Q9. IIFT is requested to consider for increasing the contract period of 3 or 5 years, as bidder / ISP has big investment to provide the link on fibre media.
