Indian Institute of Foreign Trade (IIFT) is a Deemed to be University under the administrative control of Ministry of Commerce & Industry, Govt. of India.

• The Institute invites sealed bids for providing <u>SIP Trunk Service</u>, under terms and conditions given in Tender Document.

## Terms and Conditions

- a) The prescribed tender document consisting of (i) Technical Bid and (ii) Financial Bid, sealed separately in two different envelopes, superscribing "<u>Technical Bid</u>" and "<u>Financial Bid</u>", as the case may be and placed in a duly sealed big single envelop super scribing "Bid for SIP Trunk Service for IIFT" may be submitted in the name of Accounts Officer (Finance Section.), at the Main Gate, Indian Institute of Foreign Trade, 1583, Madurdaha, Chowbagha Road, Ward No. 108, Borough XII ,Kolkata-700107 by due date. The bids may be sent through post also so as to reach at the aforesaid address by 3:00 p.m. of due date.
- b) EMD of <u>Rs.6,000/-</u> (Rupees Six Thousand Only.) in form of DD from a Scheduled Commercial Bank / Nationalized bank, in favour of "IIFT, Kolkata" need to be attached along-with the technical Bid. Bid received without EMD shall not be considered. EMD of unsuccessful bidders will be refunded without interest within one month from the award of the contract.
- c) MSME & NSIC registered vendors are exempted from paying EMD amount. NSIC & MSME registered vendors are eligible for EMD exemption on submission of valid certificates.
- d) The bidder shall provide at least three customer references to whom similar services are being provided during last one year with their contact details along with Work Orders or Completion Certificates.
- e) Financial Bids will be opened only of those bidders, who will qualify on the basis of technical bids. Institute's decision, in this regard would be final.
- f) Rates must be quoted only in the **prescribed format of Financial Bid (Annexure II)** as attached.
- g) The Institute at its discretion may award the contract for providing SIP Trunk Services to Internet Service Provider (ISP). The Institute decision in this regard would be binding on all bidders.
- h) The firm awarded the contract is required to submit performance guarantee equivalent to the 03% of the order value within fifteen days from the date of order(may be revised on further Notice from Department of Expenditure, Govt. of India). The Performance Guarantee may be in form of DD or bank Guarantee from a scheduled commercial bank in the name of "IIFT, Kolkata".
- i) Successful bidder(s) shall be required to install and operationalize the link within <u>30 days</u> of award of contract, failing which the bank guarantee will be forfeited. The Institute may also take action as it deems fit against such firm(s).
- j) Payment shall be released at the end of every three month of services subject to the services being found satisfactory to be certified by the authorized IIFT personnel. 99% or higher will be treated as satisfactory service, below which it will be treated as unsatisfactory service for which proportionate deduction will be made. In the case of continuous un-satisfactory services, IIFT may terminate the contract.

- k) The Institute reserves the right to reject any or all bids without assigning any reasons whatsoever.
- Minimum Contract Period is one year, which may be extended on mutually agreed terms and conditions. However, if the services are found not to be satisfactory, contract may be terminated by giving 60 days' notice by IIFT, Kolkata.
