INDIAN INSTITUTE OF FOREIGN TRADE (IIFT) invites sealed tenders under two-bid system from reputed and experienced agencies for <u>SUPPLY OF SKILLED /</u> <u>SEMI-SKILLED / UNSKILLED WORKERS ON CONTRACT BASIS</u> at the above address for further deployment.

The interested agencies are required to submit the technical and financial bid separately. The bids in Sealed Cover-I containing "<u>Technical Bid</u>" super-scribed "Technical Bid for Supply of Skilled / Semi-Skilled / Unskilled Workers on Contract Basis" and another Sealed Cover-II containing "<u>Financial Bid</u>" super-scribed "Financial Bid for Supply of Skilled / Semi-Skilled / Unskilled Workers on Contract Basis" should be further placed in a third sealed cover super-scribed "<u>Tender for SUPPLY OF SKILLED / SEMI-SKILLED / UNSKILLED WORKERS ON CONTRACT</u> BASIS" and should reach IIFT, Kolkata by 14:00 hrs on or before 03/03/2021. After technical evaluation of bids, the financial bids of only those bidders who qualify in technical evaluation for which checklist is given in Annexure-IV shall be opened. The date of opening of Financial Bid will be intimated later on to the responsive bidders only. Bidders are advised to write their current phone number in the attendance sheet at the time of opening the technical and financial bids.

#### CONTENTS AND ELIGIBILITY CRITERIA

- The Tenderer / Bidder shall have at least <u>03 years</u> experience in these fields and shall submit <u>self-attested copies</u> of the following documents along with the tender documents:
  - a) PF Registration with **PF code number.**
  - b) ESI Registration with number.
  - c) Valid Licence issued in respect of previous employers by Regional Labour Commissioner (i.e. <u>Govt. of West Bengal).</u>
  - d) <u>Details of works of similar nature carried out</u> in Central / State Govt. Bodies / Department / PSUs / Autonomous bodies / industries / factories or other similar organization in the last 03 years ending on 31<sup>st</sup> March 2020.
  - e) Proof showing at least one currently valid contract in similar field.
  - f) Copies of audited balance sheet and Profit & Loss A/c of previous three (03) financial years ending 31<sup>st</sup> March 2020 duly certified by CA.
  - g) List of Arbitration cases (if any).
  - h) Copies of certificates / allotment letter of GST and PAN Number.
  - i) Details of managerial, supervisory and other staff members.
  - j) Undertaking of the agency confirming the availability of the adequate manpower of requisite qualification and experience for deployment at **IIFT**, **Kolkata**.
  - k) Copy of Last income tax return.
  - I) Other documents as mentioned in checklist (Annexure-IV).
- 2. Certificates provided for the works detailed in 1 (d) above shall clearly indicate the scope and nature of work undertaken and the value of various components of work as executed, in order to confirm conformity to the defined similar works.
- 3. Approximate number of **SKILLED / SEMI-SKILLED / UNSKILLED WORKERS** required in IIFT is given in **Annexure-I**. The actual number may vary as per the requirement of the Institute.
- 4. Tenderer / bidder shall submit details of organizations, where he has undertaken such similar services as per **Annexure-II**.
- 5. General Terms and Conditions of the Contract to be fulfilled by the Tenderer /

Bidder are given in **Annexure-III** and the bidder shall submit it with technical Bid duly stamped & signed on each page in lieu of agreeing to them.

- 6. Tenderer / bidder shall submit details as per checklist given in **Annexure-IV** along with the Technical Bid.
- 7. The bidder may be a proprietary firm, Partnership firm, Limited Company, Corporate body legally constituted, as per law with valid registration on the last date of submission of the bid.

#### 8. The bidder should have a full fledged registered office in Kolkata.

- 9. There should be no case pending with the police against the proprietor / firm / partner or the company (Agency). <u>The firm should give such an undertaking with their bid.</u>
- 10. The bidder has to submit of "Bid Security Declaration" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents. Bids received without "Bid Security Declaration" shall stand rejected and thus, shall not be considered for evaluation at any stage.

# 11. The selected agency should migrate all the existing manpower deployed at Indian Institute of Foreign Trade (IIFT), Kolkata Campus to their roll without any cost and pay the existing salary / wages.

- (a) In case the selected agency fails to provide or supply the manpower as required and to the satisfaction of IIFT, the Institute will advertise the vacancy through appropriate medium and select the suitable manpower.
- (b) The agency will not charge or collect any fee from any outsourced employee / IIFT on account of additional requirement of manpower other than the agreed service charge. IIFT at its own discretion can engage the staff as per its requirement for which no cost except the service charge is payable to the contractor.
- 12. The bidder (including NSIC / MSMEs who are registered with the designated bodies) shall furnish performance guarantee in the form of Bank Guarantee from any scheduled Commercial Bank to IIFT for an amount equal to 3% of the value of purchase order within 14 days from the date of issue of Purchase Order by IIFT. The Bank Guarantee Bond shall be valid for 18 months, in the Performa provided in Bid Document.
- 13. The bid shall be valid and open for acceptance of the Competent Authority of IIFT for a period of 90 days from the date of opening of the tenders and no request for any variation in quoted rates and withdrawal of tender on any ground by successful bidder shall be entertained during this period.
- 14. An agreement shall be signed with the successful bidder as per specimen enclosed.

- 15. Counter Terms & conditions will not be accepted as also any additions / deletions or change in our format will not be allowed.
- 16. All entries in the Tenders must be written in ink or typewritten. Over-writing should be avoided. Corrections, if any, should be attested with signature by the bidder.

## 17. The properly sealed tender should be sent by Registered post or deposited in the Reception / Security Guard Room, at the Main Gate of IIFT, Kolkata.

18. Tenders received late (including postal delay)/in open condition/without Bid Security Declaration/not meeting the tender condition/incomplete in any respect are liable to be rejected.

#### 19. Conditional bid, if any, shall be rejected.

 Bid process shall be cancelled in the event of receipt of single responsive bid. Tendering process shall be finalized only when there are at least two responsive bids.

**Note:** Selection of the bidder would be made after taking all the relevant factors like past performance, credentials, responsible business practices, competency to execute such contracts, credentials of fulfillment of provisions of labour laws with past contracts and above conditions into account together. Evaluation of these parameters shall be based on the documents and information submitted by the bidder(s) without recourse to extrinsic evidence. In a normal situation, the contract shall be <u>awarded to the party quoting the lowest service charge</u>. However, mere lowest service charge is not the sole criteria of selection. IIFT is not bound to accept the lowest rates. Without affecting the sanctity of the above criteria, IIFT has the power to relax any condition of eligibility criteria qualifying the bid(s) based on the merit of each case and, if the situation so warrants, in the interest of work of IIFT.

## 21. <u>IIFT reserves the right to accept or reject any or all bids without assigning any reasons.</u>

- 22. IIFT also reserves the right to reject any bid <u>(including the lowest one)</u> which, in its opinion, is not responsive or violating any of the conditions/specifications or which is found to be adopting unethical business practices; without bearing any liability or any loss whatsoever it may cause to the bidder in the process.
- 23. Bidders are advised to study carefully the tender documents and the conditions before quoting their bid. All the pages of the tender form should be sealed & signed by the bidder as a token of acceptance.
- 24. The rates should be indicated both in words and figures. In case of discrepancy between the figure (number) and words, the rates given in figures or words whichever is lowest only will be taken as authenticated and no further clarification will be sought from the bidder.

25. No party shall be permitted to tender for work in IIFT in which any of their near relatives is an employee connected with the award and execution of the contract. They shall also intimate the names of persons who are working with them in any capacity or subsequently employed by them and who are near relatives of any employee of the IIFT or in the State or Central Government. Any violation of this condition which comes to the Notice of IIFT after the contract is awarded will entitle IIFT to treat the contractors as having committed a breach of contract and to exercise all the rights and remedies available to IIFT on account thereof.

The above clause is as per the standard practice for such tender and may be reviewed.

26. <u>EXPERIENCE:-</u> Providing Back-office staff service will only be considered as similar works. Any other services like Housekeeping/Peon/Security etc. Services will not be considered in this category.

#### DRAFT ARTICLES OF AGREEMENT

This Agreement is made on \_\_\_\_\_day of \_\_\_\_\_two thousand \_\_\_\_\_ between INDIAN INSTITUTE OF FOREIGN TRADE, as one part, hereinafter called "IIFT" and M/s.\_\_\_\_\_\_as another part hereinafter called "Agency" for providing SKILLED / SEMI-SKILLED / UNSKILLED WORKERS on the other part.

WHEREAS, IIFT is desirous to engage the Agency for providing SKILLED / SEMI-SKILLED / UNSKILLED WORKERS for IIFT at Kolkata on the terms and conditions stated below:

- 1. The agency <u>shall be solely responsible</u> for compliance to provisions of various Labour, Industrial and any other laws applicable and all statutory obligations, such as wages, allowances, compensations, EPF, Bonus, Gratuity, ESI, etc. relating to contract personnel deployed in IIFT. IIFT shall have no liability in this regard.
- 2. The Agency shall be solely responsible for any accident/medical/health related liability/compensation for the personnel deployed by it at IIFT. IIFT shall have no liability in this regard.
- Any violation of instruction/agreement or suppression of facts will attract forfeiture of Bank Guarantee and cancellation of agreement without any reference or any notice period.
- 4. The contract can be terminated by giving three months notice on either side.
- 5. However, even after the termination of the contract, if any work is hampered due to the withdrawal of any manpower, he will be allowed to complete the work in hand or till the time any other alternative arrangement is made, on the existing terms and conditions.
- 6. In case of non-compliance with the contract, the Institute reserves its right to:
  - a) Cancel/revoke the contract, and /or
  - b) Impose penalty up to 10% of the total annual value of contract.
- 7. Performance Security Deposit of Rs.3,00,000/- (Rupees Three Lakhs only) (refundable without interest after two months of termination of contract) in the form of Bank Guarantee from a scheduled commercial bank shall be furnished within 14 days from the date of issue of Purchase Order by the IIFT.

- 8. The Agency shall be fully responsible for timely monthly payment of wages and any other dues to the personnel deployed in IIFT by 7<sup>th</sup> of every month strictly through NEFT, irrespective of the fact whether the payment of its bill submitted to IIFT has been released by the Institute or not by that date. If 7<sup>th</sup> day of a particular month happens to be a holiday, the agency may be required to make payment of wages to its staff on a working day prior to the 7<sup>th</sup> day of such month. Further the agency while submitting their bill for payment shall also be responsible to submit documentary evidence of having submitted ESI and EPF amount (both employer's and employee's contribution) in the respective account of the worker for the period for which bill is raised, copies of challans and worker's permanent ESI account card / certificate.
- 9. The personnel provided by the Agency will not claim to become the employees of IIFT and there will be no Employee and Employer relationship between the personnel engaged by the Agency for deployment in IIFT.
- 10. There would be no increase in rates payable to the Agency during the contract period except if IIFT desires, so or reimbursement of the statutory wages revised by the **Govt. of West Bengal** from time to time, as applicable during the contract period. As and when the wages are revised by the **Govt. of West Bengal**, the revised wages shall be paid by IIFT.
- 11. The agency also agrees to comply with the <u>Annexed Terms and Conditions</u> and amendments thereto from time to time.
- 12. Decision of IIFT in regard to interpretation of the terms and conditions and the Agreement shall be final and binding on the Agency.
- 13. The Agency has to provide Identity Cards, Appointment Letters and Joining Letters to their workers within 14 days from the date of issue of Purchase Order by IIFT.
- 14. The Agency has to provide Salary Slips / Salary Certificate in every month immediately after disbursement of salary to their workers.
- 15. The Agency shall be responsible for providing Income Certificate, Experience Certificate etc. or any other statutory documents/certificates to their workers as and when required.
- 16. In case of any dispute between the Agency and IIFT, IIFT shall have the right to decide. However, all matters of jurisdiction shall be at the courts located at Kolkata.
- 17. Forfeiture of Performance Security Deposit (Bank Guarantee):- Performance Security Deposit (Bank Guarantee) shall be forfeited, if services are not provided up to the satisfaction of IIFT or the firm withdraws its offer during currency of the contract which include the extended period of contract.

#### TERMS AND CONDITIONS OF CONTRACT FOR SUPPLY OF SKILLED / SEMI-SKILLED / UNSKILLED WORKERS

#### (Annexure to Agreement)

A. SCOPE OF WORK: <u>PROVIDING SKILLED / SEMI-SKILLED / UNSKILLED</u> <u>WORKERS ON CONTRACT BASIS</u> at INDIAN INSTITUTE OF FOREIGN TRADE, 1583, Madurdaha, Chowbaga Road, Kolkata-700107 by deploying required number of contract personnel.

#### B. TERMS & CONDITIONS:

- 1. The said contract will be initially for a period of <u>twelve months</u> commencing from the date of signing the contract which may be extended further for a period of <u>another twelve months</u> with same terms & conditions subject to mutual consent of both the parties and subject to satisfactory performance of contract. However, in normal circumstances the Agreement is terminable by giving three months notice in writing by either party to the agreement as provided.
- 2. The Contracting Agency shall render the following services to IIFT:
  - (a) To <u>SUPPLY SKILLED / SEMI-SKILLED / UNSKILLED WORKERS ON</u> <u>CONTRACT BASIS in IIFT, Kolkata. The supplied manpower should be</u> <u>competent enough to execute the office work assigned to them.</u>
  - (b) The skilled workers would be engaged for the following type of job:-

To attend to all work assigned to them by the concerned Section-incharge, which may include all official and clerical work like typing, dictation, maintenance of accounts' records manually as well as on software.

(c) The semi-skilled workers would be engaged for the following job:-

To be filled based on the nature of deployment, as per **Annexure-II** to the tender document.

- 3. From 09:00 AM to 05:30 PM from Monday to Friday. Saturdays and Sundays are holiday on account of being weekend days. They may also be called on Saturdays/Sundays for which extra payment per person per day (on pro-rata of basic wage) basis will be given. Payment for work done beyond the normal working hours shall be double the ordinary rate of wages.
- **4.** The personnel deployed shall be healthy and active. Nobody shall have any communicable diseases.
- 5. The personnel deployed shall be smartly dressed and always with Identity Card. The agency shall provide fully trained and disciplined personnel.

6. (a) In case the selected agency failed to provide or supply the manpower as required and to the satisfaction of IIFT, the Institute will advertise the vacancy through appropriate medium and select the suitable manpower.

(b) The agency will migrate the existing manpower as per the list enclosed to the roll of them.

(c) The agency will not charge or collect any fee from anyone on account of additional requirement other than the service charge.

- 7. The contractor shall bear all expenses regarding preparation of their Identity card, compensations, wages and allowances, DA, PF, ESI, Bonus and Gratuity as applicable relating to personnel engaged by him and abide by the provisions of various labour legislations including weekly off and working hours. The Contractor shall pay the wages to the personnel on or before the 7<sup>th</sup> of every succeeding month positively, irrespective of delay in payment of Bill by the **Institute** for whatsoever the reason. Wages payable shall not be less than the rate fixed by IIFT or minimum wages payment as declared by the Govt. of West **Bengal** from time to time. The contractor shall quote his rate of service charges. Contractor shall submit workers EPF number and proof of submission of EPF, ESI etc. as applicable every month for the previous month along with the monthly bill with respect to all employees deployed by him at IIFT, and in case of any difference in the amount for which documentary evidence has not been provided, IIFT has the right to deduct the amount accordingly from the bills. While depositing the applicable ESI & EPF amount in the account of respective worker, it shall be the sole responsibility of the contractor to comply with all prescribed provisions of Labour rules/Laws/Act. Further, the agency shall specifically ensure compliance of various Labour Laws/Acts including but not limited to with the following and their reenactments/amendments/modifications.
  - a) The Payment of Wages Act, 1936
  - b) The Employees Provident Fund Act, 1952
  - c) The Factory Act, 1948
  - d) The Contract Labour (Regulation) Act, 1970
  - e) The Payment of Bonus Act, 1965
  - f) The Payment of Gratuity Act, 1972
  - g) The Employees State Insurance Act, 1948
  - h) The Employment of Children Act, 1938
  - i) The Motor Vehicle Act, 1988
  - j) The Minimum Wages Act, 1948
- 8. Replacement of personnel as required by the Institute will be affected promptly by the Contractor; if the contractor wishes to replace any of the personnel, the same shall be done <u>after prior consultation/approval of the Institute</u>. The full particulars of the personnel to be deployed by the contractor including the names and address shall be furnished to the Institute along with the testimonials before they are actually deployed for the job. However, with respect to substituted personnel, payment of their ESI & EPF will be considered by the Institute subject to documentary evidence provided by the contractor in this regard. The same terms and conditions of agreement shall also be applicable to the

## substitute worker, and the contractor shall have to submit the complete details including EPF and ESI account of such worker.

- **9.** In case of any loss that might be caused to the Institute due to lapse on the part of the personnel deployed by the manpower agency discharging their responsibilities, such loss shall be compensated by the contracting Agency and in this connection, the Institute shall have the right to deduct appropriate amount from the bill etc. to make good of such loss to the Institute besides imposition of penalty. In case of any deficiencies/lapses on the part of the personnel deployed by the contractor, the Institute shall be within its right to terminate the contract forthwith or take any other action without assigning any reason whatsoever.
- **10.** In case of death or mishap leading to any injury or disability whatsoever, occurred during discharge of the duty, the compensation/legal or any other liability will solely rest with the Contractor.
- 11. That Contractor's authorized representative (Owner/Director/Partner/Manager) shall personally contact the Officer-in-charge of Administration at IIFT at least once a month to get a feedback on the services rendered by the contractor viz-a-viz corrective action required to make the services more efficient or any other related issues.

In the event of contract personnel being on long leave/absent, the contractor shall ensure suitable alternative arrangement to make up for such absence. To meet such eventualities, the contractor shall make provision for `leave reserve'.

- 12. The successful bidder would have to deposit an amount of Rs.3,00,000/- towards security deposit through Bank Guarantee from a scheduled commercial bank in favour of "Indian Institute of Foreign Trade", payable at "Kolkata" which would remain with IIFT during the contract period and no interest shall be payable on the Security Deposit amount.
- 13. If at any point of time it comes to the notice of IIFT that the contract personnel deployed are different from the list <u>provided (with attested photographs)</u>. IIFT will be well within its right to <u>impose penalty not exceeding 10% of the monthly</u> wages payable to Contractor for each such personnel identified. In addition to penalty clauses, the IIFT is at the liberty to levy <u>liquidated damages</u>. which may <u>be up to 10%</u> of monthly bill, for defaults on the part of the contractor.
- 14. The contract personnel deployed by the contractor shall have the required qualification. In case of non-compliance/non-performance of the services according to the terms of the contract, the IIFT shall be at liberty to make <u>suitable deductions (ranging from 2% to 10%)</u> from the bill without prejudice to its right under other provisions of the contract.
- **15.** The contractor shall be solely liable for all payment/dues of the workers employed and deployed by him with reliable evidence provided to IIFT. In the event, IIFT makes any payment or incurs any liability, the contractor shall indemnify IIFT completely.
- **16.** In case of any dispute arising out of this agreement, IIFT shall nominate any

officer of IIFT as Sole Arbitrator to adjudicate upon the issue involved in the dispute and the provisions of the Arbitration Act shall be applicable.

- In case of any dispute with regard to providing services and interpretation of any clause of the Agreement, <u>Kolkata Court</u> will have the jurisdiction to settle and decide all the disputes.
- **18.** Income Tax TDS as per rules shall be deducted from the bills of the contractor as per applicable laws.
- **19.** As and when IIFT requires additional contract personnel on temporary or emergency basis, the contractor will depute such personnel in accordance with pro-rata rates. For the same, a notice of two days will be given by IIFT.
- **20.** Any violation of instructions/agreement or suppression of facts will attract cancellation of agreement without any reference.
- **21.** In case IIFT suspects or finds any work is entrusted to any sub-contractor on piecemeal basis or on regular terms, IIFT reserves the right to terminate the contract without assigning any reasons.
- 22. Personnel engaged for day-to-day work should not be utilized for carrying out the occasional work for which the contractor has to engage extra personnel if demanded by IIFT.
- **23.** The contractor will be held wholly responsible for any action taken by statutory bodies for violation/non-compilation of any such provision/rule.
- 24. The contractor should maintain all the records and documents under various labour laws applicable to contract labours / personnel and also Shops & Establishment Act / Rules applicable to his/her establishment and make them available at IIFT at all times. Indicative list of such records is given for example: (a) Register for Workmen, (b) Employment card (to be issued to workers), (c) Muster Roll, (d) Register for wages, (e) Wage slip, (f) OT register etc.
  - (a) The above records and the following returns filed by the contractor have to be produced to the Admin. Department of IIFT on demand and original/photocopies of these records should be handed over after completion of the contract. Return in Form 5, 10 & 12A which is submitted monthly under the provisions of the Employees' Provident Funds & MP Act, 1952.
  - (b) Summary of contribution (Form 5) under Sec. 44 Regulation 25 of the ESI Act, 1948. Also the return filed under Sec. 44, Regulation 26 of the said act along with the monthly return.
  - (c) Half yearly return in Form XXIV under Rule 82(1) of the Contract Labour (R&A) Act, 1970.
  - (d) Annual return filed in Form 3A/6A under the Employee's Provident Funds & MP Act, 1952.

- (e) Annual Return in Form III Rule 21(4 A) of the Minimum Wages Act, 1948.
- (f) Any other applicable return.
- 25. <u>The contractor should obtain a Licence from Labour Commissioner to engage the</u> <u>Contract labour / personnel at IIFT as per Contract Labour Act within a period of</u> one month from the date of award of contract by IIFT.
- 26. The contractor shall ensure that the payment of wages to his personnel deployed for carrying out his contractual obligations shall not be less than the minimum wages prescribed by the <u>Govt. of West Bengal</u> from time to time, as applicable during the contract period. As and when the wages are revised by the <u>Govt. of West Bengal</u>, the revised wages shall be paid by IIFT.
- 27. The Contractor should ensure payment of wages to his workmen on or before 7<sup>th</sup> of every succeeding month positively irrespective of the fact whether the payment of its bill submitted to IIFT has been released by the Institute or not by that date. If seventh day of a particular month happens to be a holiday, the agency shall required to make payment of wages to its staff on a working day prior to the seventh day of such month. The payment of wages will be made only through electronic means. The proof of payment would be submitted to the Institute.
- **28.** The wages shall be paid to workmen without any deduction except those under the payment of Wages Act and Minimum Wages Act.
- **29.** The Contractor should ensure that his workmen are granted Holidays / Leave with wages as per applicable Act / Rules.
- **30.** The IIFT reserves its rights to withhold bills, if the contractor fails to produce proof for having remitted the ESI / PF dues. <u>The payment for successive months</u> will be released on receipt of the evidence of deposition of ESI / PF in the worker's account for previous month.
- **31.** The Contractor has to submit the attested photocopies of his voter ID, PAN, residential address, educational qualifications etc. He should also give the list of his sons and relatives who are working in this office as sub-contractors or the labourers. If there is no such thing, the contractor has to give an undertaking to this effect.
- **32.** If any of the personnel of the contractor indulges in theft or any illegal/irregular activities, misconduct, the contractor will take appropriate action as per law and rules against its erring personnel in consultation with this office and intimate the action taken to this office. If need be, an FIR should be lodged against the erring personnel. Such personnel, who indulge in such type of activities, should not be further employed in this office by the contractor in any case.
- **33.** Whenever there is a duplication of clause either in the terms and conditions or in the agreement, the clause which is beneficial to IIFT will be considered applicable at the time of any dispute following any statutory rules.

- **34.** Contract Agreement should be executed within 21 days of the issue of letter of acceptance. Non-fulfillment of this condition of executing a contract by the Contractor would constitute sufficient ground for annulment of the award and forfeiture of BG.
- **35.** Late bids i.e. bids received after the specified date and time of receipt, shall not be considered.
- **36.** The resultant contract will be interpreted under Indian Laws.
- **37.** The successful bidder should depute a person who shall be the point of contact for all official purposes. The person should be well aware of the tender terms & conditions.
- **38.** Any vendor who has worked with IIFT and violated any of the tender terms & conditions in past three years are barred from participating in this tender.

# Note: These terms and conditions are part of the Contract / Agreement as indicated in the Agreement between IIFT and the Agency and any non-compliance shall be deemed as breach of the Contract / Agreement.

#### The criterion of selection as well as rejection:

a. The contractor will demonstrate to IIFT the following to be able to qualify for consideration at the stage of technical evaluation: i.e. only those Bid(s) shall be treated as responsive bid(s) which fulfils all the criterion/parameters as mentioned below:

#### i. At least three years standing in the field.

- ii. Experience of providing such or similar services to the Central/State Govt. Departments / Autonomous bodies / PSUs / Industries / NGOs etc. **during** last 03 years.
- iii. At least one currently valid contracts for similar works to offices of Central/State Govt. Department / PSUs / Autonomous bodies / industries / or other similar organizations.
- iv. Submission of 'Bid Security Declaration' and all documents mentioned in the checklist (Annexure-IV).
- v. Conditional bid, if any, shall be rejected.
- b. Incomplete tenders would be rejected. Further, the rejection criterion is mentioned in Annexure-IV [Checklist].
- c. Bid process shall be cancelled in the event of receipt of single responsive bid. Tendering process shall be finalized only when there are at least two responsive bids.

**Note:** Selection of the bidder would be made after taking all the relevant factors like past performance, credentials, responsible business practices, competency to execute such contracts, credentials of fulfillment of provisions of labour laws with past contracts and above conditions into account together. Evaluation of these parameters shall be based on the documents and information submitted by the bidder(s) without recourse to extrinsic evidence. In a normal situation, the contract shall be <u>awarded to the party quoting the lowest service charge</u>. However, mere lowest service charge is not the sole criteria of selection. IIFT is not bound to accept the lowest rates. Without affecting the sanctity of the above criterion, IIFT has the power to relax any condition of eligibility criteria qualifying the bid(s) based on merit of each case and if the situation so warrants in the interest of work of IIFT.

#### d. <u>IIFT reserves the right to accept or reject any or all bids without assigning</u> any reasons.

- e. IIFT also reserves the right to reject any bid <u>(including the lowest one)</u> which in its opinion is not responsive or violating any of the conditions/specifications or which is found to be adopting unethical business practices; without bearing any liability or any loss, whatsoever, it may cause to the bidder in the process.
- f. Any bidder who is not satisfied with the conditions of the contract, bidding conditions, bidding process or the rejection criteria may represent to IIFT mentioning his arguments etc. before the last date of receipt of tender but not later than the opening of financial bids.
- g. The selected agency should migrate all the manpower at present deployed in IIFT without any cost to their roll and pay the current salary.
