

## About the Institute

The Indian Institute of Foreign Trade (IIFT) was established in 1963 as an autonomous organization under the aegis of the Ministry of Commerce & Industry, Government of India, to contribute in the skill building for the external trade sector of India. The Institute's portfolio is spread over a number of long-term MBA Programmes, which include: two-year MBA (International Business), two year MBA (Business Analytics) two-year & six months MBA (International Business) (Weekend), Executive Post Graduate Diploma Programmes in International Business, etc., to name a few. Detailed information on the MBA Programmes offered by IIFT at New Delhi, Kolkata, and Kakinada campuses as well as through VSAT / online modes can be obtained from the Institute web-page (www.iift.ac.in).

In addition to MBA teaching, the Institute has trained about 50,000 business professionals across more than 30 countries in various facets of international business and trade policy through its Management Development Programmes. Detailed information on the MDP programmes offered by IIFT can be obtained from the Institute's web-page (www.iift.ac.in).

The IIFT Ph.D. Programme is well-known for quality research on important business issues in national and international contexts. The programme is attended by both Part-Time and Full-Time research scholars. Most of the IIFT Ph.D. Scholars are highly placed in reputed academic institutions and universities, government departments, and leading corporate groups.

#### **DELHI CAMPUS**

Located in the Qutab Institutional Area in close vicinity of other reputed institutions such as JNU, IIT, and ISI, the Delhi Campus, spreading over six acres of land and overlooking a green ridge and the historical Qutab Minar, provides an ideal environment for academic excellence.

The facilities available on the campus include a well-equipped library, centrally air-conditioned lecture halls with modern audio-visual aids, conference halls for round-table conferences, an auditorium with 450 seating capacity, a gymnasium, and indoor games, besides quality residential facilities for the MBA students.

#### **Library Facilities**

A fully automated Foreign Trade Library is a vast knowledge bank with an impressive collection of 1,05,081 resources that comprise nearly 77,916 books/ CDs-volumes, 17,931 bound periodicals, and 235 periodicals on the subjects related to International Trade; Business such as Economics, Management, Marketing, Statistical Theory, Banking, Industries, Logistics, Global Business Environment, Geopolitical Economic System, etc. The library has access to the Bloomberg Database as well which offers a dynamic network of information for decision-makers. Bloomberg is of great value to students seeking fast access to accurate business and financial information, news, and insight around the world, in order to facilitate online access to information, IIFT Library has also subscribedto several trade and management related online and offline databases, like EBSCO, Proquest, Emerald, Blackwell, CMIE, JSTOR, Indiastat, World Trade Online, IMF Databases, OECD online, World Trade Atlas, and many more to its list.

#### **Computer Centre**

Recognizing the importance of technology in education, IIFT's Computer Centre has implemented the latest state-of-the-art IT infrastructure to provide a competitive advantage in its core areas of education and research. The Computer Centre aims at providing 99 percent uptime including ensuring server uptime, data recovery and backup, facilitating storage management, hardware, and network operations, streamlining operations, and simplifying end-user support.

For its internet requirements, the IIFT avails 250 MBPS leased line from two different ISPs onload balancing. The computer lab for the students is open 24X7 with an adequate number of desktop computers. These are fully

supported with application software such as SPSS, EViews, SmartPLS, NVivo SAS, etc. India Trade & Prowess databases from CMIE are also available on the Institute's network.

Comprehending the recent advances in functional data analysis and high-dimensional statistics, IIFT, besides the Computer Lab, has an exclusive Data Analytics & Simulation Lab (DASL) with 40 computers with software such as SPSS, Hadoop, SAS, etc. for Data Analytics and Simulation Courses.

Apart from this, IIFT also uses video conferencing facility for training, and research activities besides connecting IIFT Delhi & Kolkata for internal meetings, etc. IIFT's recent foray into the online education platform has been possible with the state-of-the-art IT infrastructure support being provided for the conduct of online programmes, which has enabled IIFT to conduct online sessions on a real-time basis using a broadband facility.

#### **KOLKATA CAMPUS**

The campus is located in IIFT's own premises in the picturesque East Kolkata off EM Bypass in a sprawling area of around 7 acres. The campus is developed as a green and fully integrated campus with independent blocks for academic, administration, and student living areas with all modern amenities. There are centrally air-conditioned modern lecture halls, syndicate rooms, a common area, an auditorium, an open-air theatre, a common courtyard in its academic and administration blocks with exemplary designs to create a great learning environment. The campus is fully under Wi-Fi.

#### Library

The library at the Kolkata Campus is gradually growing with resources and other electronic and virtual information. It is presently equipped with a collection of around 5000 books, 90+ printed national and international journals, 5,000 national & international journals (including e-journals) in the field of International Business Management and related areas, such as International Trade, Statistics, Economics, Mathematics,

Marketing, Psychology, Operation Research, Business Communication, Advertising, etc., and thesis and reports in the field of global economics and related facets. Online databases (accessible from the campus) are one of the most important and valuable resources of the library. The library provides access to over 200+ full text e-journals on economics, and databases like Economist Intelligence Unit, CMIE Prowess, Industry Outlook, and EPWRF India Time Series. Bloomberg, which is the premier source for global business and financial information, is also installed in the library.

#### **Computer Centre**

The Kolkata Campus network has been implemented totally on CISCO infrastructure. The whole campus is Wi-Fi enabled which supports 802.11b/g/n standards. Secured Wi-Fi access has been provided to allusers in the campus. Today, the campus has a multi-tiered infrastructure in place. The infrastructure is at a layer 3 switching level that helps interconnect all components of the same together on one platform. Over 700 users have access to this network. To support internet services, Kolkata Campus uses a 350 MBPS leased line from two different ISPs on load balancing mode. Digital room equipped with 30 latest desktops having all kinds of database software like SPSS, STATA, Prowess, etc. are accessible to students for their academic purposes. To conduct online classroom sessions a studio has been setup with the latest audio-visual devices that are capable of not only virtual classrooms but also live events and webinars. Apart from this, the Ph.D. Room and a few other classrooms are also equipped with video conferencing devices to conduct online or hybrid sessions and seminars.

#### **KAKINADA CAMPUS**

A land measuring 25 acres has been allotted to the Institute for setting up a full-fledged campus at Kakinada, a beautiful coastal town and a smart city in the State of Andhra Pradesh. Campus and Facilities at IIFT For the present batch of 5 years Integrated Programme in Management (BBA in Business Analytics + MBA in International Business) 2022- 27, Jawaharlal Nehru Technological University (JNTU), Kakinada has permitted IIFT to utilize its premises. The University has state of art Infrastructural facilities like Internet Connectivity, a library, playgrounds, an auditorium, a canteen, and medical services. The classrooms are fully air conditional with modern audio-visual aids

#### **PUBLICATIONS**

The Publication Division brings out IIFT Journals, Newsletter, Working Papers, and Seminar Series. Foreign Trade Review (FTR) is a peerreviewed quarterly journalhaving more than four and half decades of existence in the academic research fraternity. The journal is published by SAGE Publications India. This journal is included in the following abstracting and indexing databases: SCOPUS, Chartered Association of Business Schools (ABS); ABDC-B, Clarivate Analytics: Emerging Sources Citation Index (ESCI). The Journal intends to serve as a comprehensive forum

for theoretical and empirical research on International Trade and Business. Focus WTO, another peer-reviewed quarterly journal published by the Institute. The objective of this interdisciplinary Focus WTO is to encourage applications of conceptual ideas and research methods in international business and management. "Focus WTO is indexed under the Directory of Research Journals Indexing (DRJI), Indian Citation Index (ICI), and J Gate.

The papers are published on-line and uploaded on the IIFT website (http://focuswtoib.iift.ac.in). In addition, the Publication Division also publishes an in-house quarterly newsletter and hosts working papers and conducts seminar series.

#### **INI STATUS**

IIFT is expected to be conferred with the status of an "Institute of National Importance" in International Trade (Management and International Economics). The Bill for the same is under consideration with Government of India and is likely by approved by the Parliament of India by mid-2023.

Conferment of INI status would empower the IIFT to attain standards of global excellence in International Trade (Management and International Economics) and allied areas of knowledge.

Subsequent to conferment of INI status, IIFT-Delhi, IIFT-Kolkata and IIFT-Kakinada will become independent institutes. The degrees will be awarded by the respective institutes and similarly, placement activities may also be managed by the respective institutes.

# Ph.D. Programme (Management) at IIFT

#### **Objectives**

One of the primary purposes of the Ph.D. programme is to encourage scholars to undertake research and in-depth analysis and enrich their knowledge in their chosen field. It includes the ability to independently apply methodologies of scientific research as well as to create new scientific knowledge. Further, the scholars are expected to demonstrate an ability to critically analyze research findings and understand their importance in wider contexts, and effectively communicate and disseminate research results.

The Institute invites applications for its Ph.D. Programme (Management) Full-Time & Part-Time from both domestic and overseas candidates for the year 2023. Selected candidates for the Ph.D. Programme (Management) can attend the classes during the course work which are held on weekends.

The broad areas in which the Institute offers admission to Ph.D. Programme (Management) are:

- Finance
- General Management & Strategy
- Global Trade Operations and Logistics
- IT Innovation & Technology Management
- Marketing
- · Operations and Supply Chain Management

#### **Duration & Process**

- Ph.D. Programme shall be for a minimum duration of three (3) years, including course work (two semesters), and a maximum duration of six (6) years from the date of admission to the Ph.D. Programme.
- A maximum of an additional two (2) years can be given through a process of reregistration as per the Academic Rules, governing IIFT's Ph.D. Programme; provided, however, that the total period for completion of a Ph.D. Programme should not exceed eight (8) years from the date of admission in the Ph.D. programme.

- Provided further that, female Ph.D. scholars and Persons with Disabilities (having more than 40%disability) may be allowed an additional relaxation of two (2) years; however, the total period forcompletion of a Ph.D. Programme in such cases should not exceed ten (10) years from the date of admission in the Ph.D. Programme.
- Female Ph.D. Scholars may be provided Maternity Leave/Child Care Leave for up to 240 days in theentire duration of the Ph.D. Programme.

During the first year, selected scholars need to complete the coursework at the Institute covering two semesters. On successful completion of the coursework including the Seminar Paper and approval of the proposed research topic (Synopsis Confirmation), a confirmation certificate will be issued along with the name of the Ph.D. Supervisor. A threemember Doctoral Advisory Committee (DAC) will be set up for each scholar for his / her doctoral research. The scholar has to present his/her research progress to the DAC on a regular basis. There is a minimum period of two (2) years from the date of the synopsis confirmation seminarafter which the doctoral thesis can be submitted for external evaluation. For more details, see the rules of the Ph.D. Programme (Management).

The selection of the candidates will be based on their suitability and availability of vacancies. The Institute follows the Government of India's Rules on reservation policy in admissions.

#### **Course Structure**

Selected scholars are required to mandatorily attend course work at IIFT during the first year of the Programme. The total course work is of 13 credit hours (1 credit hour = 10 hours) including 3 credit hours of seminar paper. The course work is divided over twosemesters and classes for FullTime and Part Time will be held on weekends.

Course Structure is subject to revision by the Institute's Academic Council from time to time.

In addition to the coursework, the Full Time Ph.D. Scholars at the Institute are trained in various teaching, research, and other academic activities (e.g., offering tutorials, case presentations), helping faculty in teaching and evaluations. Ph.D. students are offered scholarship by the Institute and those with JRF, are required to be involved in teaching, research, and evaluation work.

#### **Eligibility**

The eligibility criteria for applying to IIFT's Ph.D. Programme (Management) are the following:

Indian Scholars: Ph.D. (Management) Full-Time & Part Time

- 1. Candidates who have completed
- A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or
- Equivalent qualification from a foreign educational institution. The courses must be as per the Equivalence Granted by AIU to the Institute / University during that duration.
- A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/ Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.
- Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/

- Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.
- 2. Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or itsequivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which isapproved, recognized, or authorized by an authority, established or incorporated under a law in itshome country or any other statutory authority in that country to assess, accredit or assure qualityandstandards of educational institutions, shall be eligible for admission to the Ph.D. programme. Arelaxation of 5% marks or its equivalent grade may be allowed for those belonging SC/ST/OBC(non-creamy Differently-Abled, Economically Weaker Section (EWS) and other categories ofcandidates as per the decision of the Commission from time to time.
- 3. Diploma courses that are considered equivalent to a Master's Degree (e.g., PGDIM from IIMs) with 55% marks or CGPA equivalent to B Plus, recognized by AICTE/UGC would be considered. In such cases, candidates would be required to produce the necessary certificate(s) from the Association of Indian Universities (AIU). The period of diploma courses must be as per the Equivalence Granted by AIU to the Institute / University during that duration.
- 4. Candidates who are in the final year of the above mentioned degreeprogrammeare also eligible to apply. However, if selected, their admission will be on a provisional basis. Admission of such candidates who joins the Ph.D. Program on a provisional basis but fails to obtain minimum percentage in the as defined above is liable to be cancelled forthwith. Such candidates should immediately inform the Institution of the declaration of her / his results. Admission of candidates who do not inform the Institute of such situation will automatically stand cancelled on 15th December 2023. No

request for extension of time for reevaluation, etc. will be entertained.

- 5. If the candidate is employed and applying for Part-Time Ph.D., he/she has to submit the "No Objection Certificate" from his / her employer clearly stating that:
  - The candidate is permitted to pursue studies on a part-time basis.
  - His/her official duties permit him /her to devote sufficient time for research.
  - If required, he/she will be relieved from the duty to complete the course work.

# Overseas Scholars (Only for Full Time Ph.D. Programme)

- Overseas candidates who have a Master's/ M.Phil. A degree in any discipline from a recognized university with at least 55% marks or a CGPA equivalent to B Plus in aggregate can apply only to IIFT's full-time Ph.D. Programme.
- Minimum knowledge of spoken and written English is essential.
- There is no scholarship, or residential/ hostel facility available for overseas scholars in the Institute. However, the Institute can help in the search for suitable accommodation for scholars admitted to Ph.D. Programme.

#### Number of Seats: Delhi: 22 and Kolkata: 19.

The seats mentioned above for Delhi and Kolkata Centre are for both Full-Time and Part-Time programs depending on merit and as per the reservation policy of UGC.

Age Limit: There is no age limit.

#### **Admission Process**

A two-stage process is followed for admission to the IIFT Ph.D. Programme (Management).

#### Stage I:

- All the eligible candidates will be called for the offline Entrance Exam. The entrance test syllabus consists of 50% of research methodology and 50% shall be subject specific. (as per UGC Guidelines).
- Students who score 50% marks in the entrance test are eligible to be called for the interview.
- A relaxation of 5% marks will be allowed in the entrance examination for the candidates belonging to the SC/ST/OBC/differentlyabled category, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the commission from time to time.
- The Institute may decide the number of eligible students to be called for an interview based on the number of Ph.D. seats available.
- Weightage for the entrance Exam is 70% and 30% for the performance in the interview.

#### Stage II:

 Candidates who would qualify for the Written Entrance Test will be called for the Interview.

# Exemption from Written Entrance Examination:

- UGC NET-JRF qualified candidates are exempted from the Written Entrance Examination
- UGC NET-JRF qualified candidates will be called for the interviews on the basis of their scores in the UGC NET-JRF Exam and a separate list will be released.

#### Fellowship for Full-time Ph.D. Scholar

An amount of ₹15,000/- will be offered by the Institute in the form of fellowship to a few of

the selected candidates. The amount is subject to revision by the Institute. The tenure of the fellowship will be three years and subsequently as per the rules guiding the Ph.D. Programme.

No separate HRA is admissible as per the IIFT rules.

#### **Imposing of Penalty**

If a scholar does not deposit the fee within the stipulated time, a penalty of ₹2,000/-for one month will be imposed and if it is delayed by two months a penalty of ₹5,000/- will be imposed. If the delay in depositing the fee is more than two months to twelve (12) months, a penalty of ₹12,000/- will be imposed.


