


## INDIAN INSTITUTE OF FOREIGN TRADE

## **General Terms and Conditions:**

- 1. The Indian Institute of Foreign Trade (IIFT) strives to have a workforce which reflects gender balance, hence, women candidates are encouraged to apply.
- 2. All applications must be submitted only through online mode.

- 3. The crucial date for determining the age limit shall be the last date of the receipt of applications.
- 4. The crucial date for counting of the essential educational qualifications and experiences shall be the last date of the receipt of the application. All educational qualifications must have been obtained from recognized University/Institute only.
- 5. Essential qualifications/experience prescribed are the minimum eligibility and mere possession of them will not entitle an applicant to be shortlisted or claim of appointment.
- 6. No application shall be entertained after the closing date of the application form and no subsequent request for its change will be considered or granted.
- 7. Selection/appointment/employment will be subject to fulfillment of required qualification, experience etc. and also to verification of testimonials, antecedents and past services. If it is found at any stage that any information has been suppressed or wrongly/falsely provided or any fraud has been committed, the application/appointment/employment of the concerned applicant will be summarily rejected/cancelled/terminated and the subsequent legal action shall be taken against such candidate.
- 8. Applicants selected for appointment shall be required to go through police verification, medical examination before or after joining.
- 9. Counting of past services will not be allowed if application of the candidate is not received through proper channel along with the documents consisting of releasing order, last pay certificate etc. at the time of joining the Institute, if appointed.
- 10. In case of large number of applications, the scrutiny committee may apply benchmarks higher than minimum essential/desirable qualifications to shortlist the candidates for the further process.
- 11. The selected candidates will be governed by the Institute's rules and regulations and the services of the selected candidates shall be utilized in any campus of IIFT.
- 12. Addendum/deletion/corrigendum, (if any), shall be posted on the official website of the Institute only.
- 13. Canvassing of any nature and/or bringing any influence/pressure from any quarter will be treated as a disqualification for the post.
- 14. Correspondence from the Institute shall be sent to the candidate through the e-mail ID provided by the candidate concerned.
- 15. The Institute reserves the right to fill or not to fill the post advertised if circumstances so warrant and withdraw any advertised post(s) at any time without giving any reason. No correspondence whatsoever will be entertained from the candidates regarding postal delays, conducting of the examination and results.
- 16. Any dispute with regard to this recruitment will be subject to the Courts/Tribunals having jurisdiction over Delhi.
